Remarks of John M. Abowd, Chief Scientist and Associate Director for Research and Methodology Accepting the 2022 EPIC Foundation Champions of Freedom Award (September 21, 2022)

I want to begin by thanking my family, especially my wife Janet, but also my children Kate, Maryclaire and Danny, and their spouses Anton, Mostafa and Naina. Janet and some of the rest of my family are here. I'm going to ask them to stand up so you can thank them too. [pause]

Next, I want to emphasize that I am accepting this award on behalf of hundreds of dedicated civil servants, contractors, and external Census Bureau stakeholders. They moved the agency squarely into the 21st Century: First, by acknowledging the massive shift in the information landscape that has occurred since the methods that statistical offices use to protect confidentiality were first invented in the 1970s and implemented in the two decades that followed;

Second, by working diligently, indeed feverishly, over the last six years to implement confidentiality protections supported by the best available science—the framework known as differential privacy.

These people are the champions of freedom, and I would not be standing here without their unflinching and continuing dedication to the American public.
