# Example #2 – An Act to Establish the Office of Racial Equity and Social Justice in New York State

Title: An act to amend the executive law, in relation to establishing the office of racial equity and social justice

**Short Text**: The purpose of this bill is to create an Office of Racial Equity and Social Justice.

Summary of Specific Provisions: The legislation would add a new article 15-D to the executive law. Section one provides definitions and outlines the functions of the Office of Racial Equity and Social Justice. The Official of Racial Equity and Social Justice would: Serve as the official state planning and coordinating office for changes in policy, practice and allocation of state resources so that racial or social justice constructs do not predict an individual's success; Establish, oversee, manage, coordinate and facilitate the development of the state's racial equity and social justice action plan; Facilitate racial equity and social justice training for all state employees; Advise and assist the state agencies developing policies, plans and programs for improving racial equity and social justice; Perform racial equity and social justice reviews and make recommendations for improving management and program effectiveness pertaining to racial equity and social justice, including an annual racial equity and social justice impact statement, which shall accompany the Executive Budget; and Establish, oversee and manage racial equity and social justice advisory committee. Section two establishes the effective date.

Justification: This bill would create a new office within the Executive Branch called the Office of Racial Equity and Social Justice. Although the Executive and Legislature may take actions to acknowledge or support racial equity and social justice, there is not a central entity within state government specifically created to further this critical goal. Decisions made by agencies throughout the government can have an enormously positive or detrimental effect on either reducing or exacerbating disparities that already exist. Sometimes by design, but more often unintentionally, actions by the state government have a direct impact on health, educational, and socioeconomic disparities. This legislation creates a mechanism within state government to ensure race or social justice constructs do not predict an individual's success, while also improving opportunities and outcomes for all people. Local jurisdictions, such as King County, Washington and Montgomery County, Maryland, have established offices focusing on Equity and Social Justice. This legislation would put the state of New York at the forefront of addressing systemic racism, inequality, and disparities nationwide.
