BIOGRAPHICAL SKETCH

Karim-Aly S. Kassam is International Professor of Environmental and Indigenous Studies in the Department of Natural Resources and the Environment, and the American Indian and Indigenous Studies Program at Cornell University. Professor Kassam's aim is to seamlessly merge research and teaching in the service of communities by investigating the relationship between biological and cultural diversity. His research examines the cultural and ecological basis of pluralism. It focuses on the complex connectivity of human and environmental relations, addressing Indigenous ways of knowing, climate change, food systems, and sustainable livelihoods. This research is conducted in partnership with Indigenous communities in the Circumpolar Arctic, Boreal Forest, as well as the Pamir Mountains of Afghanistan, Kyrgyzstan, Tajikistan, and Xinjiang. Through applied research and teaching, he articulates a rigorous methodology and pedagogy of hope. Through research and teaching, Professor Kassam strives to speak truth to power.

In 2024, Professor Kassam was awarded the "Freedom of Expression" Fellowship for his work as a Global Public Intellectual. In 2023, the Faculty Senate of the American University of Central Asia (AUCA) awarded him Professor Honoris Causa "in recognition of his contributions to the culturally grounded community-based research on climate change adaptation in Central Asia, and sponsoring and supporting AUCA Students". In 2023, Professor Kassam also received the Community-Engaged Practice and Innovation Award from the David M. Einhorn Center at Cornell University for commitment and ability to integrate community engagement with Indigenous peoples into courses, leadership and research programs. Separately, he was named the 2023-24 Faculty Fellow in engaged Learning. In 2022, he was awarded the Kendall S. Carpenter Memorial Advising Award for a deep commitment to the wellbeing as well as intellectual and personal growth of undergraduate students at Cornell. In 2021, during the pandemic, he successfully organized the international "in-person" conference entitled Rhythms of the Land: Indigenous Knowledge, Science, and Thriving Together in a Changing Climate, safely bringing together over 80 Indigenous and non-indigenous students, community leaders, scientists, and policy makers from the Arctic to Alpine regions of Central Asia to present research findings from transdisciplinary community-based research to build anticipatory capacity for the climate crisis. This conference simultaneously featured exhibits by international artists entitled Art and Environmental Struggle at the Johnson Museum of Art and an exhibit interpreting his research findings entitled Ecological Calendars; Finding Hope in the Face of Climate Change at the Cornell Botanic Gardens. The conference was result of a \$1.35 Million Ecological Calendars for Climate Adaptation Project (ECCAP) funded in 2016 which he led. In 2020, Professor Kassam was awarded the Global Public Fellowship to engage with wider society through art, poetry, and essays on current issues of justice. In 2017, he was awarded the University of Bayreuth (Germany) International Senior Fellowship for his contributions to the Faculty of Biology, Chemistry and Earth Sciences. In 2013, he received the College of Agriculture and Life Sciences Diversity Award for creating and fostering diversity in research and teaching. From 2008 to 2011, he was Director of Graduate Studies of the American Indian and Indigenous Studies Program. Prior to joining Cornell, Dr. Kassam was Associate Professor with the Faculty of Communication and Culture at the University of Calgary, Canada. In 2006, he received the Teaching Excellence Award from the Students' Union at the University of Calgary. He also received Teaching Excellence Awards in 2002 and 1999. In 2003, he was the first Canadian to receive the Organization of American States-Fulbright Ecology Fellowship. He founded the Theme School in Northern Planning and Development Studies at the University of Calgary in 1995 and was its first Director until 2003. From 1998 to 2001 he was the first Murray Fraser Professor of Community Economic Development at the University of Calgary. In 2003, Venture Magazine named him one of Alberta's 50 most influential people along with business and political leaders. Professor Kassam is currently Faculty Fellow of the Cornell Botanic Gardens and the Cornell Atkinson Center for Sustainability.

Professor Kassam holds a PhD in Natural Resource Policy and Management from Cornell University, an MSc in Social Policy and Planning in Developing Countries from the London School of Economics, an MPhil in Islamic Studies from the University of Cambridge, and a BA in Economics from the University of Calgary.
